4. First aid measures

4.1. Description of first aid measures

4.2. Most important symptoms and effects, both acute and delayed

5. Fire-fighting measures

5.1. Extinguishing media

6. Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Immediately evacuate personnel to safe areas. Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Fully encapsulating, vapor protective clothing should be worn for spills and leaks with no fire. Do not breathe vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them. 6.2. Environmental precautions
